### **Requirements for Renewing LICSW**

Information taken from the <u>Licensed Independent Clinical Social Worker</u> on the Department of Health Website states:

"Social workers must renew their license every year on or before their birthday. Thirty-six hours of continuing education (CE) with six hours in law and ethics is due every two years. Social workers are required to submit the appropriate fee, renewal card and an affidavit of compliance with the continuing education requirement. Beginning with the first full CE period after January 1, 2014, social workers must complete six hours of training in suicide assessment, treatment and management. The training must be repeated once every six years."

Of these 36 hours that can be completed, only 26 of those hours per reporting period can be using distance learning programs. See <u>Social Worker and Social Worker Associate Continuing Education Frequently Asked Questions</u> for more details. It states that

"Distance learning programs must be approved by an industryrecognized local, state, national or international organization or institution of higher learning. These programs must require tests of comprehension upon completion. Limit distance learning programs

to 26 hours per reporting period."
